# Our Terms and Conditions for Online Money Transfer Service

These Terms and Conditions (the "Agreement") govern the use of the online money remittance services (the "Services") provided by Clydestone UK Ltd registered in the United Kingdom (Company registration number 08116062) with our registered office at Sobus Hub, 196 Freston Road. London. London W10 6TT, trading as cowrieSend ("Company," "We," "Us," or "Our") to its customers ("You" or "User"). By using our Services, you agree to comply with and be bound by this Agreement. We are a payment institution registered and regulated by the Financial Conduct Authority (Registration number 925402) to provide money remittance.

# 1. Acceptance of Terms

- 1.2 If you do not agree with any provision of this Agreement, you should not use the Services.

#### 2. Services Overview

## 3. User Responsibilities

## 4. Money Transfer Process

- 4.1 You can initiate a money transfer by providing the required information, including the recipient's details and the transfer amount.
- 4.2 You are responsible for any fees associated with the transfer, which will be disclosed before you confirm the transaction.

# 5. Exchange Rates

- 5.1 Exchange rates are provided to you before confirming the transaction. The actual exchange rate applied may vary based on market conditions.
- 5.2 You acknowledge that exchange rates can fluctuate and may affect the final amount received by the Beneficiary.

# 6. Fees and Charges

- 6.1 Our fees and charges for using the Services are clearly communicated to you during the transaction process.
- 6.2 You agree to pay all applicable fees associated with the money transfer, including any additional charges levied by third-party financial institutions.

#### 7. Cancellation and Refunds

7.1 You may be able to cancel a transaction before it is processed. Refund policies and applicable charges are outlined in our refund policy, which is available on our website.

- 8.1 You agree to use the Services in compliance with all applicable laws, regulations, and sanctions.
- 8.2 We may, at our discretion, refuse to process transactions that we believe may violate any laws or regulations.

- 9.1 We collect, use, and protect your personal information as outlined in our Privacy Policy, available on our website.
- 9.2 You are responsible for maintaining the security of your account information and for promptly reporting any unauthorized access.

11.1 We reserve the right to suspend, restrict, or terminate your access to the Services at our sole discretion.
